The park entrance gate is in place for your security. Except in emergencies it will be locked as scheduled.

Please notify the gate attendant that you have left your site before exiting the park at check out.

Registration and Check-In

Valid identification and personal transportation is required for all adult campers. All vehicles are required to have current tags. Drivers must have a current license. Current Coggins papers are required for all horses.

The minimum age to rent a campsite is 18. No camping by minors under the age of 18 is allowed unless accompanied by an adult (21 or over) throughout the camping period.

A campsite suitable to your equipment and/or vehicle will be assigned by the admissions officer upon registration. If more than one suitable site is available you may be allowed to select the site of your choice.

Campers are requested to go straight to their designated campsite and set up before enjoying other areas of the park.

Only one camping unit per site is allowed in the RV and horse trailer campgrounds. Up to three tents are allowed per site in the individual and family primitive campgrounds.

No more than two vehicles are allowed to be parked at any individual camp site. Visitors should park in designated areas.

Maximum occupancy per campsite is 8 people.

Maximum stay is ordinarily 30 days in RV Campground; 5 days in primitive (tent) campgrounds and horse trailer campgrounds. Once a maximum stay is booked in any campground, there will be a minimum of one week before camper is eligible to rent any other camping facility.

Guests staying in our campsite are allowed up to four visitors per site during regular day use hours; the first two of which are free of charge (regular admission rates apply). All visitors must check in at the gatehouse and indicate who they are visiting.

All trash must be deposited in dumpsters provided. One servicing the Apalachee, Bartram, and Carson campgrounds is located at the exit of the Apalachee RV campground at its intersection with Old Blakeley Road. A dumpster servicing the Harper Tent Campground (and the Squirrel's Nests) is located near the restrooms at that campground's entrance.

Conduct

Campers are expected to be courteous of other guests, and not disturb the peace with loud talking, music or other noise.

Harming trees or wildlife in any way is not permitted. Live trees may not be cut, blazed, trimmed, or damaged in any manner.

Firearms are prohibited except where authorized by law.

Hunting and metal detecting are strictly prohibited.

Hard liquor is not allowed. Alcohol is not allowed in any public area of the park and may only be responsibly consumed by those of legal age within the confines of their campsite.

Pets must be on a leash at all times when outdoors and may not be left outside unattended.

No open fires are permitted except in fire pits.

No outside firewood of any kind may be brought into the park.

Sites must be kept neat and cleaned of trash. Excessive outdoor furniture or other items cluttering campsite is prohibited. Trash must be deposited in dumpsters.

Drainage of waste of any kind is prohibited except in the park sewage service system.

RV campers may not pour cooking grease into drains or sewage lines, and are requested to wipe down cooking vessels containing grease prior to washing.

Hammocks attached by nylon, rubber or cloth straps may be used within the campgrounds on healthy mature trees of 8" diameter or larger. Trees may not be notched, limbed, or damaged in any way to facilitate use of hammocks.

Campers in the horse trailer campground are responsible for bringing their own wood shavings for stall floors and for cleaning stalls and depositing manure in bunker before checkout.

Historic Blakeley State Park reserves the right to deny camping accommodations to anyone or to evict anyone for violations of these rules. If evicted, camp fee will not be refunded. The park also reserves the right to require the evacuation of the campground at its discretion in the event of a natural disaster. Should this happen, the unused portion of your camping fee will be refunded.
